May kindly see the online application of Sri Aditya Nath Sharma, Civil Judge (Junior Division) (FTC), Deoria by which he has requested for grant of permission to appear in the examination of Civil Services Exam 2024 conducted by Uttar Pradesh Public Service Commission.

In his application, Sri Aditya Nath Sharma has stated that he wishes to appear in UPPSC Examination 2024 and in this regard he has earlier applied for permission to appear in all the three stages of the said examination through offline mode through the Respected District Judge of Deoria on 17.02.2024. Now, his e-portal has been activated, thus, he is again uploading that application to seek kind permission of Hon'ble High Court. Thereafter, through online objection, the officer has been asked to intimate the date and stage of the said examination and also be asked to upload the notification of the same. In reply the officer has stated that he wants permission to appear in all three stages of this examination as preliminary examination date is yet to be declared. He has also enclosed his earlier offline application, notification and paper relating to date of examination, which can be seen as attachments. He has, therefore, requested for grant of permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 04.01.2024. It is pertinent to mention here that earlier on his offline application, a detailed office note dated 28.02.2024 has been prepared and also submitted to Hon'ble Administrative Judge, Deoria but due to change of Hon'ble Administrative Judge the file has returned without any order. Thereafter through Hon'ble Court's letter dated 20.05.2024, the officer has been asked to apply through e-services portal only in light of Hon'ble Court's letter dated 31.08.2019 and in compliance of the same, the officer has applied through online portal, thus now the matter is being processed through online mode. It is also to mention here that as the officer has applied for permission to appear in all the three stages of the examination but it is to submit there that permission to appear in competitive examination is granted stage-wise only i.e. not in whole and he has also not submitted the date of preliminary (1st stage) examination. Now, it is on the discretion of Hon'ble Court either to grant him permission to appear in the preliminary Examination of the UPPSC civil services examination 2024 or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Aditya Nath Sharma, Civil Judge (Junior Division) (FTC), Deoria to appear in the preliminary examination of Civil Services Examination-2024, conducted by Uttar Pradesh Public Service Commission, as requested, subject to the conditions mentioned above?
