May kindly see the online application received from Sushri Roli Tiwari, Addl. Civil Judge (Junior Division), Jaunpur regarding grant of permission to appear in Civil Services Examination 2024 conducted by UPSC.

In her application, the officer has stated that she has earlier applied for permission to complete application form and appear for above said examination via offline mode (copy of letter can be seen as attachment) as till that time she do not has access to her login Id details and now as she has received her login Id details, thus she is re-applying for the same through online mode. She has also stated that Union Public Service Commission has invited online applications for Civil services Examination vide advertisement No.- Examination Notice No. 05/2024- CSP dated 14.02.2024 and the examination would be conducted in 3 stages namely (a) Preliminary Examination (b) Main written Examination and (c) Viva voice. The preliminary exam is anticipated to be conducted on 16.06.2024 and she wants to appear in the same. She has therefore, requested for grant of permission to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined U.P. Nyayik Sewa on 04.01.2024. It is pertinent to mention here that as the officer has stated that she has applied through offline mode but in the light of Hon'ble Court's letter no. 558/XXXIII-CPC/e-Courts/Allahabad dated 31.08.2019, all the application afterwards 31.08.2019 should be entertained through online mode, thus now this matter is being processed through online mode. Now, It is desirable that she may be accorded permission to appear in the preliminary examination of UPSC Civil Services Exam 2024, stated to be scheduled on 16.06.2024, if the Hon'ble High Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur for His Lordship's kind perusal and orders to the effect that permission be accorded to Sushri Roli Tiwari, Addl. Civil Judge (Junior Division), Jaunpur to appear in the Civil Services preliminary examination-2024, conducted by Union Public Service Commission, as requested, subject to the conditions mentioned above?
