May kindly see the online application of Sushri Somya Gupta, Additional Civil Judge (Junior Division), Saharanpur, by which she has requested for grant of permission to appear in Mains Examination of Haryana Civil Services (Judicial Branch) Examination, 2023-2024.

In her application, Sushri Somya Gupta has stated that after due intimation to the concerned authorities vide endorsement No. 51/XV dated 09.01.2024, she had appeared and qualified the Preliminary Examination of Haryana Civil Services (Judicial) Branch examination 2023-2024 held on 03 March 2024 with Roll No. 34172 vide result declared on 09 April 2024 (copy of result can be seen as attachment). The schedule for holding the Mains Examination has been announced and the Mains Examination would be conducted from 12 July 2024 to 14 July 2024 at Chandigarh and she wants permission to appear in the same. Thereafter, through online objection, the officer was asked to submit her offline letter through which prelims exam permission has been sought. In reply, the officer has enclosed her offline letter (Copy of the letter can be seen under attachment heading "Haryana Judiciary Prelims Exam Permission") and Hon'ble Court's letter sent in this regard (Copy of the letter can be seen under attachment heading "Communication by Hon'ble High Court"). She has therefore requested to grant her permission to appear in the Mains Examination to be held at Chandigarh.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 04.01.2024. It is pertinent to mention here that as the officer has applied for Preliminary Examination of Haryana Civil Services (Judicial) Branch examination-2023 through offline mode and as the letter has been received in the section after the date of the examination, thus through Hon'ble Court's letter dated 17.05.2024, she was asked to intimate about her appearance and result and also be asked to submit the reply through online portal. Now, through instant application, the officer has stated that she has appeared in the preliminary examination and also passed the same and now wants to appear in the Mains examination of the Haryana Civil Services (Judicial Branch) Examination, 2023, therefore it appears to be proper to grant her ex-post facto permission for her appearance in the preliminary examination of Haryana Civil Services (Judicial Branch) examination-2023-2024 in order to regularize the matter as well as it is also desirable to accord her permission to appear in the Haryana Judicial Services (Mains) Examination 2023-24 stated to be scheduled on 12.07.2024, 13.07.2024 & 14.07.2024; as she has qualified the preliminary examination of the same, subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur for His Lordship's kind perusal and if approved Sushri Somya Gupta, Additional Civil Judge (Junior Division), Saharanpur be granted ex-post facto permission for her appearance in the Haryana Civil Services (Judicial Branch) Preliminary Examination 2023-24 as well as permission to appear in the Haryana Civil Services (Judicial Branch) Mains Examination 2023-24, as requested, subject to the conditions mentioned above?
