May Kindly see the online application of Sushri Somya Gupta, Additional Civil Judge (Junior Division), Saharanpur by which she has requested for grant of ex-post facto permission to appear in the Mains examination of Delhi Judicial Services Examination 2023.

In her application, the officer has stated that before her joining in the U.P. Judicial Services, she had appeared for the Preliminary Examination of the Delhi Judicial Services which was held on 17 December 2023 and has qualified the same. She has also stated that after due intimation to the concerned authorities vide endorsement No. 236/XV dated 07.02.2024, she had appeared for the Mains Examination of Delhi Judicial service examination 2023, which was held from 13 April 2024 to 14 April 2024 under Roll No. 575 (copy of Mains examination admit card can be seen as attachment) and the result of the Mains Examination is still awaited. She has also enclosed the result of Delhi Judicial Services preims examination which can be seen as attachment. She has, therefore, requested to Hon'ble Court to grant her permission to appear in the aforesaid Mains examination of Delhi Judicial Services Examination 2023.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 04.01.2024. It is also pertinent to mention here that the officer has appeared in the preliminary examination of Delhi Judicial Services Examination, 2023 prior to joining the U.P. Nyayik Sewa and has sought for permission to appear in the Mains examination through offline letter dated 17.02.2024 which was received in the section on 24.04.2024 i.e after the date of the said examination, thus through Hon'ble Court's letter dated 17.05.2024, she was asked to intimate about her appearance in the stated examiantion and also be asked to sent fresh application through online portal in the light of Hon'ble Court's letter no. 558/XXXIII-CPC/e-Courts/Allahabad/ Dated 31 August 2019. In compliance of the same, the officer through her instant application has applied through portal. Now as the officer has appeared in the Mains examination of the Delhi Judicial Services Examination 2024 in anticipation of grant of permission from the Hon'ble Court, which was scheduled on 13.04.2024 and 14.04.2024. Now, it is on the discretion of His Lordship either to grant her ex-post facto permission for her appearance in the Mains Examination of the same, in order to regularize the matter or to pass any other order. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders to the effect that ex-post facto permission be accorded to Sushri Somya Gupta, Additional Civil Judge (Junior Division), Saharanpur for her appearance in the Mains examination of Delhi Judicial Services Examination 2023, as requested.
