May kindly see the online application of Sri Parveen, Civil Judge (Junior Division), (FTC), Meerut by which he has requested for grant of permission to appear in Mains Examination of Haryana Civil Services (Judicial Branch) Examination, 2023-2024.

In his application, Sri Parveen has stated that he had duly appeared for the preliminary examination of Haryana Judicial Service Examination 2023-24 held on 03.03.2024 in accordance with the permission granted by the Hon'ble High Court vide letter No.1210/IV-5481/Admin(A-4) dated 27.01.2024 (copy can be seen as attachment) and he had appeared in the same and has been declared successful in the result declared on 09.04.2024 (result can also be seen as attachment). Now, the Mains examination (written) is scheduled to be held on 12-14th July, 2024 (copy of Mains admit card can also be seen as attachment). He has also assured that this would not affect his training programme in any manner whatsoever. He has, therefore requested to Hon'ble Court to grant him permission to appear in the aforesaid Mains examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 04.01.2024. It is pertinent to mention here that earlier the officer has been granted permission to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination, 2023-2024 through Hon'ble Court's letter dated 27.01.2024. Now, it is desirable that he may be accorded permission to appear in the Mains Examination of the same as he has cleared the preliminary examination, if the Hon'ble Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

- 1. Government work should not suffer in any way.
- 2. No preferential treatment will be given in the matter of leave, postings and transfer.
- 3. The permission can be withdrawn without notice if; it is found at any time the government servant neglect his normal work or that public work suffers, in any way.

May, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut for His Lordship's kind perusal and orders to the effect that permission be accorded to Sri Parveen, Civil Judge (Junior Division), (FTC), Meerut to appear in Mains (written) examination of Haryana Civil Services (Judicial Branch) Examination, 2023-2024, as requested, subject to the conditions mentioned above?
