May kindly see the online application of Sri Vishwanath Pratap Singh, Civil Judge (Junior Division), Hapur who joined service on 15.11.2019 drawing gross salary of Rs. 93,052/- & take home salary of Rs. 77,653/-(in the month of May 2022 i.e. month and year of purchase of the vehicle) regarding information about purchase of new car Skoda Slavia Ambition 1.0 TSI Model bearing registration number UP32MV7595, intimated through application dated 17.06.2024.

Through his application, Sri Vishwanath Pratap Singh, has submitted information about purchase of a new car on 29.05.2022 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Kamal Kishore Autocorp Pvt. Ltd., Authorized dealer Skoda Auto India Pvt. Ltd, 13 Rana Pratap Marg, Lucknow 226001., for Rs. 14,00,000/- (copy of sale invoice can be seen as attachment), source of money of which is that Rs. 12,00,000/- has been taken as car loan from Bank of Baroda repayable in 84 EMIs of Rs. 18,554/- (loan agreement with Bank of Baroda can be seen as attachment), rest amount of Rs. 2,00,000/- (40,000/- 49,000/- 40,000/- 20,000/- 20,000/- 31,000/-) is stated to have been paid out of his own S.B. A/c (copy of statement of A/c can be seen as attachment). Officer has further submitted that after purchasing the vehicle he received the registration certificate with wrong name of the bank of hypothecation wherein Axis Bank was mentioned instead of Bank of Baroda(copy of earlier RC & updated RC can be seen as attachment), so the officer has applied for correction in the registration certificate due to which he couldn't furnish the information within the desired time, for which officer seeks apology for unintentional delay in furnishing information. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Dr. Justice Yogendra Kumar Srivastava, Administrative Judge, Hapur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Hapur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
