May kindly see the application of Smt. Babita Pathak, Chief Judicial Magistrate, Gautam Budh Nagar regarding grant of permission to purchase agricultural land area 0.125 hec, Gatta no.988, Vill-Rajepur Manza Pargana-Haweli Awadh, Tehsil Sadar District Ayodhya through registered 'Agreement to sell' dated 01.09.2023 and her supplementary submission dated 07.08.2024 in the matter, in compliance of order dated 29.07.2024 of Hon'ble the Administrative Judge, Gautam Budh Nagar.

In this connection, it is submitted that Smt. The current balance in the Salary account is Rs. 6,79,473/- as on 07.08.2024. She has also submitted copy of Personal loan account and statement of account as attachments (attachments dated 07.08.2024 namely "Earnest Money payment and Statement of account" & "Personal loan details") for kind perusal. She has, therefore, humbly prayed that your honour may kindly be pleased to permit her to purchase land.

Under the facts and details so submitted by the officer, in compliance of His Lordship's order, may, therefore, if approved, the matter again be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautam Budh Nagar, also nominated for "Disposal of the matters of the Judicial Officers, wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Gautam Budh Nagar, for His Lordship's kind perusal and if His Lordship approves, Smt. Babita Pathak, Chief Judicial Magistrate, Gautam Budh Nagar may be granted permission to purchase agricultural land area 0.125 hec, Gatta no.988, Vill-Rajepur Manza, Pargana-Haweli Awadh, Tehsil Sadar, District Ayodhya from Sri Rakesh Pratap Singh R/o parakhan, post office Darshan Nagar, Ayodhya, Sri Abhishek Singh R/o Rajerpur Uparhar, Post Purabaza, Tehsil-Sadar, Ayodhya and Sri Dharmendra Pratap Singh R/o Village and Post Umra, Tehsil Valdira, Tehsil Sultanpur for Rs. 8,00,000/- as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by her immediately on completion of the transaction?
