May kindly see the online application of Sri Tarun Kumar, Civil Judge (Junior Division), Rath-Hamirpur who joined service on 16.12.2019 drawing gross salary of Rs. 1,50,425/- & take home salary of Rs. 1,15,862/- regarding information about purchase of new car Mahindra XUV700AX7L Diesel manual Model bearing registration number UP32PK6009 (copy of vehicle RC can be seen as attachment 'RC of vehicle), intimated through application dated 15.07.2024.

Through his application, Sri Tarun Kumar, has submitted information about purchase of a new car on 08.03.2024 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Dhruv-Tara Automobiles Pvt. Ltd., H.No. 205/1, Orai Industrial Area, Kanpur Road, opp- Hindustan Lever Limited, Orai, UP-285001., for Rs. 27,89,803/- (copy of sale invoice and quotation can be seen as attachments under heading namely 'Invoice of vehicle' and 'Quotation of vehicle' respectively), source of money of which is that loan of Rs 8,00,000/- has been taken from Bank of Baroda, repayable in 60 equitable Emi's of Rs. Rs. 16,529/- (copy of loan sanction letter can be seen as attachment), Rs. 6,00,000/- has been taken from father as gift (consent letter for gift from father can be seen as attachment) and rest amount of Rs. 13,89,803/- has been paid out of his own savings and salary. Mode of payment is that Rs. 27,68,803/- has been paid from his Bank of Baroda A/c (copy of BOB A/c statement can be seen as attachment 'BOB A/c statement') and Rs. 21,000/- has been paid from his SBI A/c as booking amount (copy of SBI A/c statement can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge Hamirpur, also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Hamirpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
