She has further stated that she wants to make a "Gift" of the aforementioned property to her real brother Mr. Shrish Kumar Singh out of natural love and affection and without any consideration. (copy of 'Sale Deed' of the plot can be seen as attachment). Moreover, it has been asked by Ld. Registrar (J) (Budget) from the officer to furnish the details whether the said property has been shown in her property statement(s) submitted to the Hon'ble Court (if any). The officer in her reply has stated that she has furnished the details in her property satement at the time of joining with statement id-P00045242021 and the same has been submitted to the Hon'ble Court (which can be seen as attachment). Therefore she has humbly prayed that Hon'ble Court may kindly be pleased to grant permission to her for gifting/transferring of the abovementioned property to her real brother.

In this connection, the relevant rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) is as under:

- 11. Gifts :- A government servant shall not without previous approval of Government :-
- (a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or
- (b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relation.

It is further submitted that as the plot is going to be gifted by the officer to her real brother, out of natural love and affection, who appears to be close blood relative being sister & brother in relation. Thus, there appears to be nothing objectionable as per above mentioned rule.

May, therefore, if approved by Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Fatehpur also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the District Fatehpur, for His Lordship's kind perusal and if His Lordship approves, Sushri Ankita Singh-III, Civil Judge (Junior Division), Fatehpur may be granted permission regarding gifting/transferring of property bearing number 676K area 0.3320 hectare situated at Gram- Mishripur, Pargana- Mohana, Tehsil- Bakshi ka Talab ,District- Lucknow to her real brother, as requested, subject to the condition that she may furnish details of the transaction alongwith relevant papers on completion of the transaction?
