May kindly see the online application of Sri Anil Kumar Singh-I, Principal Judge, Family Court, Ambedkar Nagar at Akbarpur, who joined service on 04.04.2001, drawing gross salary of Rs. 3,57,435/- & take home salary of Rs. 2,41,035/- regarding information about purchase of a new Maruti Grand Vitara Smart Hybrid Sygma car, allotted reg. no. UP32PS7177, intimated through application dated 05.08.2024.

Through his application, Sri Anil Kumar Singh-I, has submitted information about purchase of a new car on 15.07.2024 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from KTL Automobile Private Limited, Vibhuti Khand, Lucknow for Rs. 12,55,000/- (copy of invoice can be seen as attachment) after receiving exchange bonus and discounts in exchange of his old maruti car under scrap policy for old vehicles. Source of money for the car purchased is that Rs. 9,00,000/- has been taken as loan from Indian Bank, Daliganj, Lucknow repayable in 60 EMIs of Rs. 18,595/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 5,000/- is stated to have been paid via UPI as booking amount & Rs. 3,50,000/- was paid through Cheque No. 122437 Dated 14.07.2024 from salary Account No. 31988433666 SBI Greater Noida (copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Ambedkar Nagar at Akbarpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Ambedkar Nagar at Akbarpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
