May kindly see the online application of Sri Abhinav Srivastava, Metropolitan Magistrate, Kanpur Nagar who joined service on 10.07.2018, drawing gross salary of Rs. 90,979/- & take home salary of Rs. 76,856/- regarding information about purchase of a new Kia Seltos GTX Plus Petrol car, allotted reg. no. UP32 LC4512, intimated through application dated 10.06.2020.

Through his application, Sri Abhinav Srivastava has submitted information about purchase of a new car on 13.12.2019 by giving pointwise details as per Hon'ble Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Shree ASR Motorcorp, Pvt. Ltd., Kanpur Nagar for Rs. 18,38,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 16,58,000/- has been taken as loan from SBI, Kanpur Nagar repayable in EMIs of Rs 26,382/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 25,000/- is stated to have been paid as booking amount through cheque no. 465528, Rs. 1,10,000/- is stated to have been gifted to him by his father Sri Abhimanyu Lal Srivastava which has been credited to his A/c (Copy of 'consent letter' can be seen as attachment). Thus, Rs. 1,55,000/- is stated to have been paid by clubbing the gifted amount from his father through cheque no 465534 (copy of receipts & passbook of both the officer and his father can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Ajai Kumar Srivastava, Nominated Judge, through detailed office note dated 30.09.2021, placed above but the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Kanpur Nagar, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Kanpur Nagar, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
