## <u>Registrar (Judicial) (Budget)</u>

May kindly see the online application of Smt. Akansha Bansal, Additional Civil Judge (Senior Div.)/ACJM, Mathura regarding grant of permission to visit Italy alongwith her husband Sri Vipin Garg, who is an IAS Officer (District Magistrate, Tapi, Gujrat) and her daughter km. Maurvi Vipina Garg from 21.12.2024 to 31.12.2024.

In her application, Smt. Akansha Bansal has stated that she wishes to visit Italy along with her husband Sri Vipin Garg and daughter Km. Maurvi Vipina Garg from 21.12.2024 to 31.12.2024 which includes winter vacation, sunday, as well as 3(three) working days (which she will avail by taking casual leave). Officer has stated that her husband is also a government officer, posted as District Magistrate, Tapi, Gujrat and this is the only convenient time coinciding with her vacations where he can also avail leaves for foreign travel. Officer wishes to travel Italy for tour purpose only. The tour expenses would be approximately Rs.1,50,000/- per person that would be borne by the officer and her husband from their salary. She has also added that in order to apply for Visa /booking and initiate other formalities, she needs permission from Hon'ble Court to visit Italy. She has also submitted the following declaration:-

1. That by his abroad visit no dilemma is likely to create before Government of India or Government of U.P.

2. That such type of request for abroad visit has not been refused earlier.

3. That she has visited Turkey during summer vacation from 12.06.24 to 21.06.2024 after obtaining due permission from Hon'ble High Court.

4. She has also submitted the copy of her passport and A/c statements and her husband's salary account (wherein salary accounts show a balance of Rs. 4,24,572 and 1,90,994, respectively/-), which can be seen as attachments.

She has, therefore, most humbly requested to place her request before Hon'ble Court to grant her permission to visit Italy alongwith her husband and daughter for the aforesaid period.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections, no vigilance/ departmental enquiry is pending against Smt. Akansha Bansal. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case the officer is going to visit Italy alongwith her family from 21.12.2024 to 31.12.2024 for tour purpose, which includes winter vacation, sunday, as well as 3 (three) working days (which she will avail by taking casual leaves), thus, this trip appears to be a pleasure trip. However, it is on the discretion of the Hon'ble High Court either to grant her permission or to pass any order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Recently, vide order dated 01.07.2024 relating to re-constitution of Committees, Hon'ble The Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 65 of the list of Committees dated 01.07.2024, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura for kind perusal and if His Lordship approves, Smt. Akansha Bansal, Additional Civil Judge (Senior Div.)/ACJM, Mathura, may be granted permission to visit Italy along with her husband Sri Vipin Garg and daughter Km. Maurvi Vipina Garg, from 21.12.2024 to 31.12.2024 for tourism purpose, as requested, subject to approval by single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 01.07.2024 of Hon'ble The Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
