May kindly see the online application received from Sri Rajeshwar Shukla, Additional District & Sessions Judge, Bulandshahr by which he has submitted supplementary details/ papers in connection with information about getting a DBBL Gun transferred into his name from his father's name, in compliance of Hon'ble Court's order.

In this connection, it is submitted that in his earlier application, Sri Rajeshwar Shukla has moved an application for permission to get licence for the above mentioned gun on 04.04.2018 against which a Court's letter was received on 19.08.2019 that he may apply for firearm licence to the appropriate authority. But in the meanwhile, he has informed that he has already transferred the Gun into his name from his father's name without taking prior permission of this Court due to his father's sudden death & refusal of other family members to possess the inheritance of the same. Thus, the matter required regularization & it was desirable that he may be granted ex-post facto permission for the same. Therefore, the matter was submitted before Hon'ble Mr. Justice Om Prakash-VII, vide detailed office note dated 29.06.2021, upon which His Lordship had been pleased to order: -

"Officer be directed to inform whether he owns any other firearm or not and, if yes, provide details of the same."

The order was communicated online to the officer.

In reply of the Court's order, Sri Rajeshwar Shukla has stated that he has owned one (32 bore) revolver having its licence no 1199/GS Firozabad, valid upto 30.05.2022 (copy of his licence as well as renewed licence can be seen as attachment).

As such, the matter is now required to be submitted again to Hon'ble Court for further order, as proposed in earlier office note dated 29.06.2021, by taking into consideration the present reply, as submitted by the officer in compliance of Hon'ble Court's order/query.

It is also submitted that earlier the matter has been submitted before Hon'ble Mr. Justice Om Prakash-VII, Nominated Judge for the purpose vide office note dated 30.09.2021, but the same has been returned due to change of nomination and it is now likely to be submitted before Hon'ble the Administrative Judge concerned as per the order of nomination passed by Hon'ble The Chief Justice vide order dated 28.10.2021.

May, therefore, if approved, the file be laid before Hon'ble Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahr, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the district Bulandshahr for His Lordship's kind perusal & if His Lordship approves, Sri Rajeshwar Shukla, Additional District & Sessions Judge, Bulandshahr may be granted expost facto permission about getting the Gun transferred from his father's name into his name.
