He has therefore requested to grant him permission to appear in the Document Verification on 20th September 2024 and to issue "No Objection Certificate" for appearing in the Interview of 32nd Bihar Judicial Service Competitive Examination (Adv. No.: 23/2023).

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 01.03.2024.
