May Kindly see the online application of Sri Vishal Thakur, Civil Judge (Junior Division), (FTC), Budaun by which he has requested for grant of permission/ issuance of 'No Objection Certificate' for appearing in the interview of Haryana Civil Services (Judicial Branch) Examination, 2023-2024.

In his application, Sri Vishal Thakur has stated that before joining Uttar Pradesh Judicial Services, he had appeared in Preliminary exam of Haryana Civil Service (Judicial Branch) and thereafter appeared in the Mains examination of the same which was held on 12th, 13th, 14th July, 2024 and an application for permission to appear in Mains Examination of Haryana Civil Service (Judicial Branch) was also submitted to the Hon'ble High Court. Now, the result of aforesaid Mains exam was declared and he has been shortlisted for VivaVoce/ Interview, which is scheduled to be held on 20th September, 2024 in Chandigarh (relating paper can be seen in the attachment). He has, therefore, requested to Hon'ble Court to grant him permission/ 'No Objection Certificate' to appear in the Viva-Voce of Haryana Civil Services (Judicial Branch) Examination-2023-2024.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 11.03.2024. Earlier, through the case Id. S00046952024, the officer had applied for grant of permission for his appearance in the Mains examination of Haryana Civil Services (Judicial Branch) examination 2023-2024 and the same is at the level of Hon'ble the Administrative Judge, Budaun, at present. In the meanwhile, the officer has appeared in the stated Mains examination in anticipation of Hon'ble Court's permission and also passed the same and now requesting to grant him permission/ 'No Objection Certificate' for appearing in the interview/ viva-voce of the same, scheduled on 20.09.2024. Now as the officer has qualified for the interview of the aforesaid examination, his case for issuance of 'No Objection Certificate' for the same may be taken favourably, if the Hon'ble Court desires so.

May, therefore, if approved, the instant matter kindly be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal & if His Lordship approves 'No Objection Certificate' be issued, offline, under the signature of Registrar (Judicial) Budget in favour of Sri Vishal Thakur, Civil Judge (Junior Division), (FTC), Budaun for appearing in the interview of Haryana Civil Services (Judicial Branch) Examination 2023-2024, as requested?
