May kindly see the online application of Smt. Mirza Zeenat, A.D.J. (FTC), Budaun regarding grant of permission to visit Dubai (U.A.E.) to attend a family function there from 25.12.2024 to 06.01.2025 alongwith her husband and kids.

In her application, Smt. Mirza Zeenat has stated that she wants to visit abroad i.e. Dubai, U.A.E. during her winter vacation alongwith some casual leaves for the purpose of attending a family function which is to be organised by her elder sister on 4th of January, 2025 in Dubai (U.A.E.) and for that purpose, she has submitted an application also for sanction of casual leaves separately (copy can be seen as attachment). She has also stated in her application that her real sister, Mirza Tarannum resides in Dubai and she is organising a family function, proposed to be organised on 4th January 2025 and the officer wants to attend that function. She has also added that duration of her stay would be of 13 days i.e. from 25.12.2024 to 06.01.2025 and added that from 01st January to 06th January 2025, she would take casual leaves (as winter holidays are from 25.12.2024 to 31.12.2024 and 05.01.2025 is Sunday). She has further stated that she would stay with her husband and two kids in her sister's house, thus there would be no expenses in fooding and lodging. The expenses on the tickets would be around Rs.1,60,000/- and that would be borne from her saving bank account (copy of account statemnet having balance amount of Rs.11,57,621/- can be seen as attachment). She has also submitted following declaration/ information as per the Hon'ble Court as per Hon'ble High Court's Circular letter no. 16/ IV f-101/ Admin (A) dated 27.05.2017:-

- That by her abroad visit no dilemma is likely to be create before Government of India or Government of U.P.
- That such type of request for abroad visit has never been refused to her earlier.
- That She has never visited any foreign country earlier.
- Copy of passports of the officer, her husband and kids can also be seen as attachment.

She has, therefore, requested to place her request before Hon'ble Court to grant her permission to visit aforesaid country.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, provided by concerned sections, no vigilance/ departmental enquiry is pending against Smt. Mirza Zeenat. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. Now, in the instant case as the officer has stated that duration of her stay would be of 13 days i.e. from 25th December 2024 to 06.01.2025 which includes 05 working days of the Court and relating to these working days, the officer has stated that her real sister is organising a family function on 04.01.2025 and being a part of the family she also wants to attend the same alongwith her husband and kids, thus this trip appears to be a family obligation. For the visit the officer has also stated that from 25.12.2024 to 31.12.2024 there are winter holidays and from 01.01.2025 to 06.01.2025, she would take casual leaves. Now, it is on the discretion of the Hon'ble High Court either to grant her permission or to pass any order which deems to be proper. In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble The Chief Justice or any member of the Administrative Committee authorised by Hon'ble The Chief Justice. Recently, vide order dated 01.07.2024 relating to re-constitution of Committees, Hon'ble The Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 65 of the list of Committees dated 01.07.2024, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to visit abroad.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun for kind perusal and if His Lordship approves, Smt. Mirza Zeenat, A.D.J. (FTC), Budaun may be granted permission to visit Dubai (U.A.E.) to attend a family function there from 25.12.2024 to 06.01.2025 alongwith her husband and kids, as requested, subject to approval by single

Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 01.07.2024 of Hon'ble The Chief Justice relating to re-constitution of Committees, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
