May kindly see the online requisition/application dated 23.09.2024 of Sushri Akanksha Pathak, Additional Civil Judge (Junior Division), Gorakhpur, for inclusion of Ph.D. Degree in her service records and addition of the realted title i.e. prefixing the word "Dr." before her name. In view of the above, Sushri Akanksha Pathak has furnished the duly scanned & attested copy of Degree Qualification of Ph.D. as well as copy of permission letter of this Hon'ble Court to pursue the aforesaid course, as supporting documents for the same.

An objection dated 25.09.2024 was raised by this office to furnish the copy of permission letter of Hon'ble Court to pursue the aforesaid Ph.D. course and also to furnish the duration of Ph.D. course. In reply thereto, Sushri Akanksha Pathak has furnished the duly attested copy of desired documents by attachment dated 26.09.2024 and also submitted that the duration for submission for thesis of Ph.D. i.e. three to five years.

In this connection, it is submitted that Sushri Akanksha Pathak, joined U.P. Judicial Services on 01.03.2024 as Additional Civil Judge (Junior Division), Gorakhpur. Besides, as evident from submitted copy of degree of Ph.D., Sushri Akanksha Pathak was awarded the degree of Doctor of Philosophy (Ph.D.) on 13.07.2024 in the year 2024 from Dr. Ram Manohar Lohia Naational Law University, Lucknow, on the topic "MEDIA TRIAL AND INFRINGEMENT OF RIGHT TO REPUTATION AND PRIVACY: CONTEMPORARY ISSUES AND CHALLENGES" after joining the U.P. Judicial Services, with due permission of this Hon'ble Court to pursue the aforesaid course.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of Ph.D. degree may be included in her service-records & prefixing word of "Dr." be added before the name of Sushri Akanksha Pathak, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that aforesaid online application dated 23.09.2024 of Sushri Akanksha Pathak, Additional Civil Judge (Junior Division), Gorakhpur may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, If approved, the matter may kindly be placed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur, for His Lordship's kind perusal and approval to the effect that a copy of aforesaid online application dated 23.09.2024 along with attested copy of Ph.D. degree as well as attested copy of form of U.P. Nyayik Sewa of Sushri Akanksha Pathak, Additional Civil Judge (Junior Division), Gorakhpur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders in the instant matter ?
