May kindly see the online application of Sri Aman Shukla, Judicial Magistrate, Mahoba who joined service on 18.11.2019, drawing gross salary of Rs. 84,118/- & take home salary of Rs. 71,675/-regarding information about purchase of a new Honda City ZX car, allotted reg. no. UP78GB7140, intimated through application dated 03.07.2020.

Through his application, Sri Aman Shukla has submitted information about purchase of a new car on 14.02.2020 by giving pointwise details as per Court's C.L. no. 25/ Admin (A) dated 13.07.1998, according to which the car has been purchased by him from M/s Smart Cars Ltd., 9/2, Allenganj, Kanpur for Rs. 13,51,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 11,60,000/- has been taken as loan from SBI repayable in 84 EMIs of Rs. 18,650/- (copy of loan arrangement letter can be seen as attachment), Rs. 21,000/- is stated to have been paid as pre-booking amount out of his S.B. A/c no. 20461531288 (copy of receipt can be seen as attachment) & Rs. 1,70,000/- is stated to have been paid as down payment through cheque to the dealer (copy of passbook can be seen as attachment). It is pertinent to mention here that an amount of Rs. 1,40,000/- is stated to have been transferred to his A/c by his uncle (Sri Savinay Kumar Shukla) as gift for the purchase of the aforementioned car (copy of 'consent letter' of his uncle can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 16.07.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Mahoba, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
