A/c no. 12910100039982, Bank of Baroda (copy of statement of A/c of the officer can be seen as attachment), Rs. 10,000/- is stated to have been paid online through NEFT by her father (Sh. Kamal Prakash Sharma) from his S.B. A/c no. 10849343631, SBI (copy of statement of A/c of her father can be seen as attachment) rest Rs. 11,000/is stated to have been paid in cash by her father from his savings (copy of receipt can be seen as attachment). It is pertinent to mention here that her mother has been receiving monthly rental income from a house in her name and therefore, she has been filing her own income tax returns through her PAN No. JQKPS4811L. Her father Shri Kamal Prakash Sharma had joined CBI/New Delhi in 1989 and presently he is posted as Dy. Supdt. of Police in New Delhi. He is in 31st year of service. He is to retire on 30.09.2023.
