May kindly see the online application of Smt. Vidushi Meha, the then Judicial Magistrate, Lucknow presently posted as Secretary, District Legal Services Authority, Chitrakoot regarding information about purchase of plot no. 1056, measuring 167.445 sq. m., Eldeco City situated at village Mubarakpur, Mutakkipur, Distt. Lucknow through sale deed dated 28.07.2020, intimated through application dated 18.08.2020.

In this connection, it is submitted that in her earlier application, Smt. Vidushi Meha has stated that she along with her spouse has purchased the aforementioned plot from Eldico Housing & Industries Ltd., Regd. office. Eldico Corporate chamber I, II floor, Vibhuti khand, Gomti Nagar, Lucknow through its director Sri Brijendra Kumar Singh S/o Sri Tirth Raj Singh for a sum of Rs. 60,98,381/-. The matter was submitted before Hon'ble Mr. Justice Om Prakash-VII, vide online office note dated 14.06.2021. Thus, His Lordship had been pleased to order:

"In the office note details of E.M.I. to be paid by the Officer concerned is not mentioned." The order was communicated to the officer.

In reply of the Hon'ble Court's order, the officer has stated that she along with her spouse has jointly taken a loan from SBI of Rs. 69,20,000/- whose no. of EMIs is 204. But later on they have switched on to HDFCL for home loan of Rs. 93,00,000/- repayable in 240 EMIs of Rs. 70,991/-. Thus on 01.03.2021, the HDFCL has paid a sum of Rs. 67,62,649/- through cheque no. 206009 to their SBI Home Loan A/c & has closed their loan account (Copy of the same can be seen as attachment). Therefore a sum of Rs. 35,496/- each is stated to be debited every month from her P.N.B. A/c no. 1346001100000022 on 10.06.2021 as well as from her spouse's S.B. A/c no. 32961641467, S.B.I on 10.06.2021. (copy of statement of A/c of both the officer as well as her spouse can be seen as attachment).

The matter was submitted before Hon'ble Mr. Justice Om Prakash-VII vide detailed office note dated 20.07.2021, upon which His Lordship has been pleased to order:-

"Office to report as to whether officer has submitted property statement timely or not."

In this connection, it is submitted that the officer has submitted property statements for the financial year 2016-17 on 16.08.2019 & 2017-18 on 15.04.2019 through offline mode however, belatedly, the same were required before 31.03.2019 respectively.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Chitrakoot also nominated for "Disposal of the matters of Judicial Officers, wherein permission /information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal & further order in the matter of information about purchase of plot no. 1056, measuring 167.445 sq. m., Eldeco City situated at village Mubarakpur, Mutakkipur, Distt.
