May kindly see the online application of Sushri Vandana, presently posted as Civil Judge (Junior Division) (Fast Track court), Meerut who, joined service on 13.12.2019, drawing gross salary of Rs. 84,188/- & take home salary of Rs. 71,675/- regarding information about purchase of a new Maruti Swift Dzire car, allotted reg. no. UP15 DE0652, intimated through application dated 01.09.2020.

Through her application, Sushri Vandana has submitted information about purchase of a new car on 04.02.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Tanya Automobiles Pvt. Ltd., 35, Chandra Kiran, Chippi Tank, Meerut who is a regular & reputed dealer, for Rs. 8,09,650/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 6,56,784/- has been taken as loan from Kotak Mahindra Prime Ltd., repayable in 60 EMIs of Rs. 13,678/- (copy of loan arrangement letter can be seen as attachment), Rs. 25,650/- is stated to have been paid out of her S.B. A/c & Rs. 80,000/- is stated to have been borrowed from her friend Mr. Rajeev Kumar (copy of statement of A/c of the officer can be seen as attachment). Rs. 60,000/- is stated to have been discounted from the cost price of the car. It is also pertinent to mention here that the borrowed amount is stated to have been returned back to Mr. Rajeev Kumar by the officer (copy of statement of A/c as well as receipts of payment can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 03.09.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Meerut, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Meerut, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
