A/c no. 39012440768 (Copy of passbook can be seen as attachment) & Rs. 80,000/- is stated to have been paid by his father through RTGS (copy of 'gift deed' & passbook of his father can be seen as attachment). The source of income of his father (Sri Parasnath Yadav) is that he is a farmer by profession and they have a joint family having around 10 bigas of agricultral land , two tracters and one cowshed. His father used to regulate and manage all related affairs like selling of crops, vegetable arising out of agriculture and selling of milk and milk by product in local market. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for the District Rampur for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
