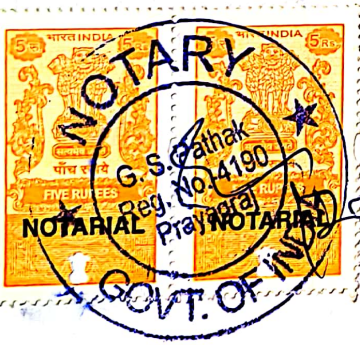

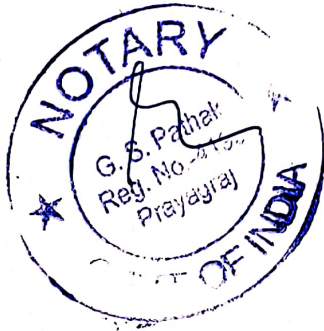

It is also submitted that my wife is also patient of Genetic Disorder of APOA5 (NM 001371904.1) with Hypertriglyceridemia. Her treatment is undergoing in Delhi AIIMS.

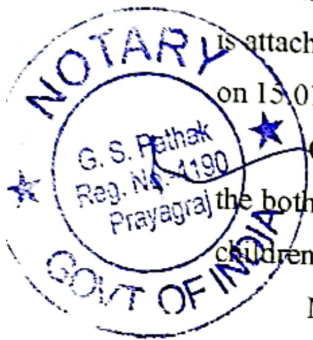
On 13.10.2023 the Treating Doctor of Genetic Disorder refer my wife for the Treatment of Eyes due to high change in eyesight which is (-)11. (Prescription of AIIMS doctor is attached). It is also submitted that on the advice of AIIMS doctor both eyes were operated on 15.01.2024 at Manohardas Eye hospital Prayagraj.

On 13.10.2023 the Treating Doctor of Genetic Disorder also advised to check-up for the both children of Hypertriglyceridemia. (Prescription of AIIMS doctor and reports of the children is attached)

My wife and children live with me. It is very difficult to continue her treatment from Prayagraj because of every doctor of AIIMS gives his own date for treatment which varies from two weeks to one month. It is also mentioned that my Mother-in-law was dies in Jan-2022 due to Hypertriglyceridemia.
