Respected Sir,

In Compliance of the direction given by Hon'ble High Court in Letter No-73/ Admin (Services) / 2024 dated 8th February, 2024 on the above mentioned subject is submitted as under:-

01- That I am posted as Civil Judge (J. D.) / Judicial Magistrate at Pharenda, an Outlying Court of District Maharajganj, U. P. , since May, 2023. I will be completing half of my tenure with Annual transfer cycle of this year. I have applied for an early transfer on grounds of my spouse working in Telangana Judicial Services & on medical grounds of my father.

02- That my spouse, Suman Grewal is member of Telangana Judicial Services and is presently working as Metropolitan Magistrate at Hyderabad. We have been married since July 2021 & still are in process to strengthen our matrimonial bond. We have also suffered a miscarriage in 2022 which is still a concern for our future family planning.

03- That my father Shri Arvind Nijhawan aged 70 years presently is severely suffering from acute respiratory disease, Chronic Obstructive Pulmonary Disease (COPD) since 2016 & has been hospitalised frequent times in attacks of breathlessness. The nature of his disease requires continuous monitoring & immediate medical attention in cases of emergency.

04- That I hereby submit the Doctor's certificate of KMC Digital Hospital, the only trauma centre of Maharajganj, which expressly cites lack of emergency medical facilities at Maharajganj, which is duly verified by the Chief Medical Officer, Maharajganj.



05- That I hereby submit my affidavit regarding the ground for my premature transfer.

06- That it is most respectfully prayed that Posting order, Pay slip and Identity Card of my wife, Suman Grewal alongwith Medical certificate and documents of my father Shri Arvind Nijhawan and my affidavit be placed with my premature transfer application before the Hon'ble High court.

06- That it is most respectfully prayed to the Hon'ble High Court that considering the above facts. I may be transferred form District Maharajganj to any of the following Districts-
