I Manoj Kumar Tiwari son of Sri Ramarcha Tiwari, age about 43 years posted as Additional District and Sessions Judge-5, Varanasi, make oath and state as follows:-

1. My mother Smt. Urmila Tiwari age about 63 years was suffering from severe anaemia from the month of October 2023 and she suffered heart failure due to her serious illness due to which she was referred for better treatment at SGPGI, Lucknow on 22/12/2023.
2. Due to her serious condition my mother was immediately admitted at immunology ward of SGPGI Lucknow on 27/12/2023 where she has been diagnosed with serious illness ANCA related Vasculitis (MPO+25.9) due to which she has suffered two heart failures within a month and her kidneys are also adversely affected and hence she was admitted there till 10/01/2024 and for her treatment i have to visit SGPGI, Lucknow, at regular intervals so that regular doses of chemo/injection can be administered to her.
3. I am the only son of my parents and my elder sister is already married and her income status is not good also she is presently residing at District Sidhi (M.P.) with her family and hence she is unable to regularly accompany my mother for her treatment at SGPGI, Lucknow.
4. My father Sri Ramarcha tiwari is 65 years old pensioner who gets a minimal amount of Rs. 18,000/- as monthly pension and he presently resides at Village-Kathar, post-

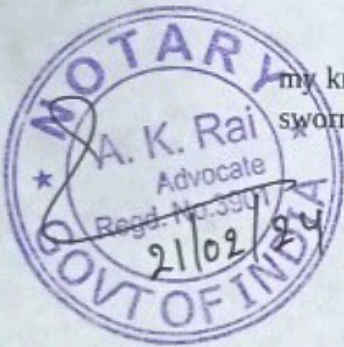

Karaundia, Tehsil- Churhat, Distt- Sidhi (M.P.) and due to his age and economic capacity he is unable to regularly accompany my mother for her treatment at SGPGI, Lucknow .

5. Since the disease my mother has been diagnosed with, needs long term specialized treatment which is not normally available at ordinary health institutions therefore for proper treatment and well being of my mother most respectfully i pray before the Hon'ble Court to consider my annual transfer to District Court Lucknow or it's adjoining Districts.
6. In compliance of Hon'ble Court's circular letter no. 73/Admin.(Services)/ 2024; dated February 08, 2024, i am hereby submitting documents related to serious medical condition and treatment of my mother at SGPGI, Lucknow in support of transfer application which are duly countersigned by Chief Medical Officer, Varanasi.
7. Hence i request your goodself to put this application alongwith the annexed documents before the Hon'ble Court for kind perusal and further action with regard to my transfer to District Court Lucknow.
