**Dear Sir,**

We have pleasure in offering you the post of **Member (Legal)** in Consumer Grievance Redressal Forum for **BSES Rajdhani Power Ltd. (BRPL)**, for a period of **three (3) years** or till attaining the age of 67 years whichever is earlier on contract basis from the date of joining as per the DERC letter No. F.9(252)/DERC/JS/2022-23/C.F.No.7518/1496 dated 30.09.2022, on the following terms and conditions:

You will be paid a consolidated emolument of **Rs. 1,00,000/-** per month (Rupees One Lac only) with 5% annual increment.

1. You will be entitled for a Car with a driver for official use only.
2. You will not be eligible for any Dearness Allowance, City Compensatory Allowance and House Rent Allowance.
3. You will not be eligible for Leave Travel Concession (LTC) or Medical Facilities.
4. During the period of your services, you will be entitled to 30 days of Earned Leave for every year of services completed. You shall also be entitled to 8 days casual Leave and 2 Restricted Holidays in a calendar year.
5. During the period of yours services :
  - a. You will be diligently performing duties allotted you.
  - b. You will not engage directly or indirectly in any work, business, and trade of any kind whatsoever of carry out other assignment except with the prior permission of the Company.
  - c. You will obey all lawful commands of the Company and other persons put in authority over you by the Company.
  - d. You will be subject to rules and regulations of the Company from time to time as regards discipline and work.

e. You shall not disclose any information regarding the affairs of the company, which comes to your knowledge during the period of your services, the disclosure of which is likely to be prejudicial to the interest of the company.

6. During the tenure of the contract, you may relinquish charge of the office by giving in writing to DERC a notice through **BSES Rajdhani Power Ltd.**, of not less than three months.

7. After completion of the contract, commencing from the date of joining, this contract shall stand terminated, if not extended further.

8. You will be required to produce your original certificates in support of your date of birth, educational qualification, and PAN card etc. with copies thereof.

9. In the event of doubt of any of the above terms and conditions or any other matter not specified and included herein, the matter shall be referred to DERC. The decision of DERC shall be final and binding on all concerned.

10. Your Joining shall be subject to submission of oath on your day of joining which shall be administered by Honorable Chairperson DERC.

11. You are required to submit an appropriate affidavit containing following declarations:

That I/My –

- a. Have not been adjudged an insolvent.
- b. Have not been convicted for an offence involving moral turpitude.
- c. Have not been physically or mentally incapable of acting as such member.
- d. Have not acquired such financial or other interest as is likely to effect prejudicially my functions as member.
- e. Have not so abused my position as to render my continuance in office prejudicially to the public interest.
- f. Have not been guilty of proved misbehavior.
- g. Appointment is subject to character and antecedent's verifications, medical examination etc.
- h. Shall abide by the provisions of DERC notification dated 11/03/2004 (enclosed).


