My wife is suffering from above disease and living in danger, my wife urgently required uterus removal surgery. Dr. Vinita Sharma also advised immediate surgery. I filed all medical certificate with endorsement of CMO.

I am permanent resident of Delhi where my other family member are also residing. I want to give best medical treatment and desired to conduct medical surgery of removal of entire uterus along with overies in Delhi so that my wife's life can be saved. I have applied premature transfer from district Kushinagar to any district, those are


mentioned in my premature application. I may be transferred to any district nearby Delhi so that my wife can get best treatment of surgery.

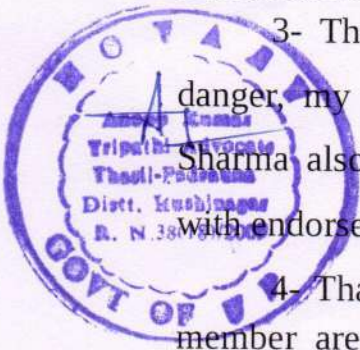
