



Renal scintigraphy performed after intravenous administration of 5 mCi Tc99-m DMSA and multiple static images were acquired at 3 hours.

**FINDINGS**

Left kidney is normal in size with irregular shape. Cortical uptake is inhomogeneous, with focally reduced tracer uptake at the lower pole.

Right kidney is normal in size with irregular shape. Cortical uptake is inhomogeneous, with reduced tracer uptake at the upper and lower poles and cortical indentation at multiple sites.


Increased background activity noted, suggestive of impaired renal function.


Subject:-Request for verification of Medical prescriptions and disease in compliance of The Hon'ble High Court's letter no.-73 /Admin (Services)/ 2024; Dated February 8, 2024 and letter no.-94 /Admin (Services)/ 2024; Dated February 19, 2024

Respected Sir,

1. It is my humble submission that The Hon'ble High Court issued a letter no.-73/Admin (Services)/2024; Dated February 8, 2024 regarding submission of certain documents in support of their grounds mentioned in the transfer application. The Hon'ble High Court has directed to the Judicial Officers who are seeking transfer on the ground of serious/critical illness of their own/their parents/their family members, to submit the latest (not more than 6 months old) documents pertaining to treatment of their own/their parents/family members duly verified/ countersigned by the Chief Medical Officer of the concerned district and in case of medical ground of self, spouse or children, the officers shall specify the district where the better medical treatment is available for the illness given in the application for transfer.
2. In Furtherance of the earlier letter, The Hon'ble High Court issued direction vide letter no.-94 /Admin (Services)/ 2024; Dated February 19, 2024 that the CMO/CMS will issue assessment report with his independent opinion in the prescribed performa about disease/disability and The District Judge to get these matter expedited from the office of the CMO and The Chief Medical Officer will retain the documents placed before them for issuance of the certificate for future reference.
3. I would like to submit that Archana Singh is my wife and her both kidneys are damaged and she is a patient of **Chronic Renal/Kidney Disease (CKD/CRD)**, and her treatment was earlier done at Sir Gangaram Hospital, New Delhi and Medanta Hospital, Gurgaon, but due to financial crisis, she is currently being treated by Dr. Sandeep Mahajan, Nephrologist, All India Institute of Medical Sciences, New Delhi.

4. It is also my humble submission that my wife's creatinine remains between 2.5 to 3.5, and due to chronic kidney disease other parts of the body also often get infected and affected, which can be treated only by a nephrologist and for this reason, Bareilly, Ghaziabad, Lucknow, Meerut, Moradabad and Bulandshahr districts have been preferred by me in the annual transfer form.
5. Therefore, it is my humble request kindly verify the medical reports in the light of relevant papers those are annexed with this letter and assess the diseases or opinion in the prescribed performa issued by The Hon'ble High Court and retain the one set of documents placed before you for future reference.
