Subject: - Representation for premature transfer to Distt. Agra on spouse ground as per G.O. dated 05.01.1976 as well as on medical ground.

Hon'ble sir,

It is most respectfully submitted that I have applied for premature transfer on e-services portal. In the present changed circumstances I am submitting following additional grounds in addition to the earlier representation dated 31.12.2023 applied on e-Services portal, for your kind and sympathetic consideration: -

1. That my wife Smt. Deepti Vatsa is also a government servant and She is working as Regional Tourist Officer in U.P. Tourism Department. Recently She has been transferred to Distt. Agra by the U.P. Govt. on medical grounds for her ongoing treatment. (Certificate of posting attached for kind perusal.)

2. That my wife was diagnosed for a tumor in her breast which the doctor strongly suspected of being cancerous (Atypia with Hyperplasia). She had to immediately undergo Oncological surgery for removal of the tumor by Oncological (Cancer) Surgeon of Pushpanjli Cancer Care Institute Agra. Thereafter She is under regular follow-up and treatment at the above said Cancer Institute at Agra. (Medical prescriptions and discharge papers duly countersigned by CMO Agra and proforma-I signed by CMO Farrukhabad attached for kind perusal)

3. That unfortunately she has been again diagnosed for developing tumor in the same breast in the month of November last year. Oncological Surgeon have now advised her to be in regular follow-up and treatment for the recently developed tumor so that the Cancer may not spread to other parts for her body further deteriorating her present condition.

4. That in the present changed circumstances where my wife has been recently transferred to Distt. Agra on her medical grounds and undergoing treatment. It is very essential for me take care of my wife and provide all sort of support to her and also take care of my tender aged only child who is residing with her mother at Agra presently.

5. That while applying online for premature transfer there was a column for 'Request of Station' which was mandatory to be filled. In that column the option of 'District Agra was somehow not displaying and when I tried to submit the online representation without filling any station in the column for 'Request of Station' the online representation could not be filled/submitted on the e-Services portal as the column for 'Request of Station' which was

a 'mandatory field' to be filled. Therefore I filled the options of stations 'Jhansi' in the coloumn for 'Request of Stations' instead of 'Agra'. Request of station be read as 'Agra' in place of 'Jhansi'

6. That it is very necessary that I should be posted at same place where my wife is currently posted and undergoing her treatment i.e. Distt. Agra.

I most humbly request you to kindly place my additional representation in the present changed circumstances before Hon'ble Court for sympathetic and kind consideration **for my premature transfer from District Farrukhabad to District Agra** on spouse as well as medical grounds.

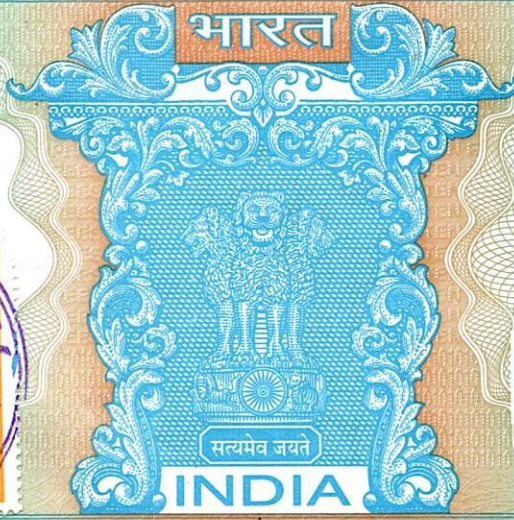
