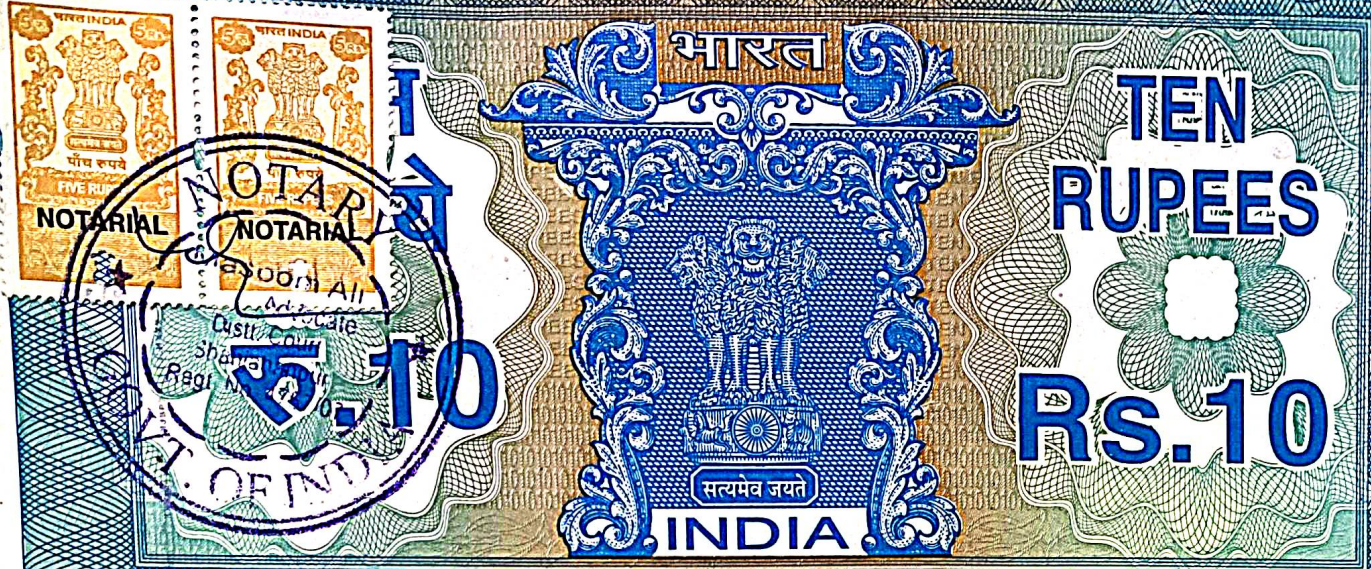

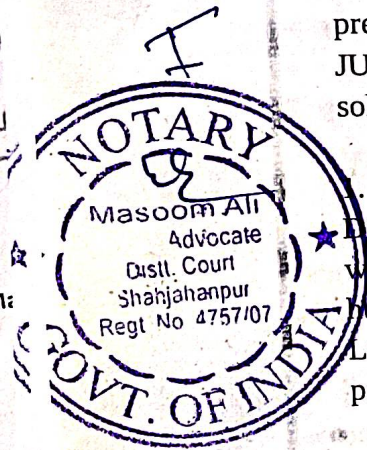
AFFIDAVIT

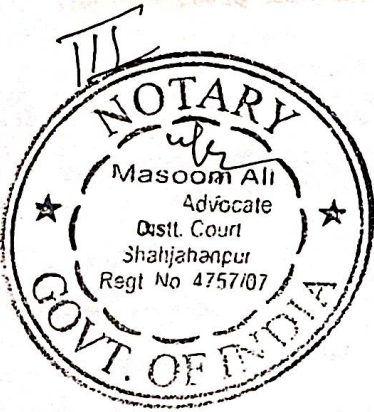
