I, Akhileswar Prasad Mishra, son of Shri Suresh Chandra Mishra, aged 46 years, resident of J-19, Judges Colony, District-Mau, do hereby, solemnly affirm on oath and state as follows:--

(i). That I have applied for my pre-mature transfer from District-Mau in annual chain of transfers in 2024.--

(ii). That I have been transferred to Mau while my younger son Parthsarathi Mishra is studying in 9th Standard in Delhi Public School, Kalyanpur at Kanpur Nagar and the elder one Arpit Mishra is preparing for JEE Mains from coaching at Kanpur Nagar. This is also worth mentioning that they are in tender age, therefore, proper guidance and supervision alongwith care is must, which is not possible from my present remote posting. --

(v). That my mother Mrs. Vimla Mishra is suffering from Hypertension, B.P. and Diabetes "LRTI, WITH COPD, T2DM, HTN, Dyslipidemia" and requires close medical monitoring. Her treatment is going on at Kanpur Nagar. For her treatment also, I need a posting near to Kanpur Nagar. Medical facilities at

District Mau are not at par with that of Kanpur Nagar. Some times, she requires urgent and immediate care and attention which is not possible from my present remote posting.—

(vi). Sir, if I am transferred to any neighbouring district of Kanpur Nagar, I would be able to guide my children and take care of my parents and family properly.—

I, therefore, request and state to consider my pre-mature transfer sympathetically and graciously.—

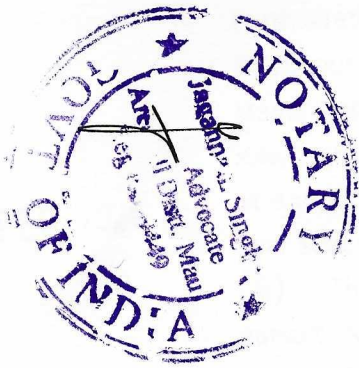
