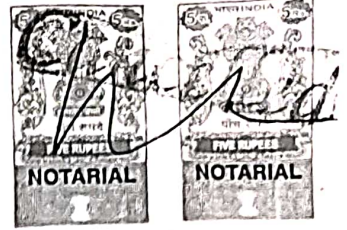
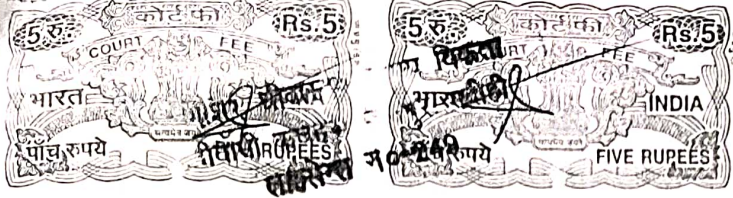

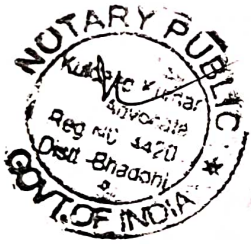


Affidavit
