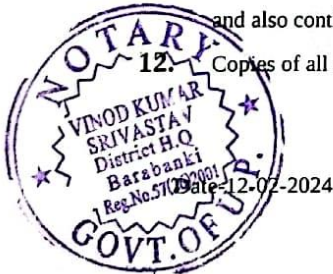
1. My Child Ashar Zishan khan Suffers from "Autism and Impairment in Socio Adaptive Functioning" since Birth.

My lord, my child aged 7 years is unable to speak properly and struggles with everyday task. I submit with pain that he struggles with basic "ABCD" and simple tasks such as eating. Mylord he is at very tender age and his entire future is at a crucial juncture. The therapy he is undergoing is critical for his future.



3. He has been diagnosed as such in a District government hospital, Barabanki. **He is undergoing treatment at "NEURO PSYCHIATRY CENTER" in Lucknow and Speech and Behaviour therapy at "Umeed Kiran Special School and rehabilitation Centre" in Barabanki.**
4. Mylord, my son suffers from "Impairment in Socio Adaptive Functioning" which means he does not receive changes in environment and location well.
5. It is humbly submitted that the Primary doctor treating him in Lucknow him has a grasp at his history and his peculiar condition.
6. The rehabilitation and speech therapy he is under undergoing requires continuity as the treatment depends on an ongoing process based on personal knowledge of the treating doctors regarding the progress of the patient.
7. **Mylord, better treatment is available at District Lucknow.**
8. The District Lucknow is not being shown in DC Portal Options.
9. **The CMO, Barabanki has duly certified and signed that my son Ashar Khan suffers from the disease and requires continuous treatment. The duly signed certificate in original is annexed herein for the kind perusal of the court.**
10. The "Umeed Kiran Special School and rehabilitation Centre" has certified that the discontinuation in therapy is not recommended.
11. Mylord, if I am transferred to District Lucknow I shall be able to avail better facilities and also continue the ongoing treatment/rehabilitation as well.
12. Copies of all medical papers is also annexed herein for the kind perusal of the court.
