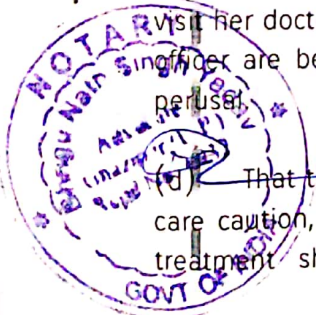




(f) That any district near district Muzaffarnagar would make her treatment easier, effective & convenient.




