**Subject: Regarding request for stay in district/transfer to nearby district**

Respected Sir,

With all due respect, I humbly submit that in accordance to Notification/Appointment No. 261/Admin (Services)/2023, dated 26<sup>th</sup> January, 2023 Hon'ble Allahabad High Court, I took charge as Civil Judge (Jr. Div.), Gautam Buddh Nagar on 27/01/2023.

I have been blessed with a baby on 23<sup>rd</sup> October 2023 (Enclosed Birth Certificate as Annexure-I). My husband and mother-in-law stay in Ghaziabad, Uttar Pradesh. My mother-in-law, aged 54 years doesn't keep well and she is suffering from high diabetes & Cervical spondylosis and require continuous medical attention/ caring (Enclosed medical reports of Mrs. Anjana as Annexure-II & Latest medical records as Annexure-V). My baby was born through a complicated Caesarean Section surgery which makes me uncomfortable when sitting continuously for long duration. Doctors have advised me to avoid long and regular travel (Enclosed medical reports as Annexure-III). I am the eldest child of my parents. My father & mother stay in New Delhi. My father, aged 58 years, underwent an open heart surgery and is presently undergoing treatment for Arterial Thrombosis – Blood clot in Delhi (Enclosed medical reports of Mr. Pawan Kumar Gupta as Annexure-IV & Latest medical checkup as Annexure- VI). My father-in-law recently passed away due to Covid. My

husband has a permanent occupation in Ghaziabad. My baby and mother-in-law are totally dependent on me and I am solely responsible to look after them.

Conversely, my family cannot stay with me as their treatment is going on in nearby medical facilities. My baby needs to be taken to hospital, located near my residence of Ghaziabad, for vaccination and other medical necessities. At times, we have to rush him to doctor for emergency medical attention. I have consulted this doctor right through my pregnancy and hence this doctor has all my medical records and knows quite well. Thus, it will be almost impossible to look after my family members, especially my new born baby - who requires instant & continuous care – if I get transferred to some other district. It will be medically risky for my baby too.

Therefore, keeping in mind my above mentioned compelling circumstances, please sympathetically consider my request for stay at District headquarters and in the unfortunate event of this not being possible kindly consider my posting in nearby districts like Hapur, Baghpat, Meerut, Amroha; so that I can fulfill my judicial commitments and at the same time look after my family.

I shall be forever grateful for this act of kindness.

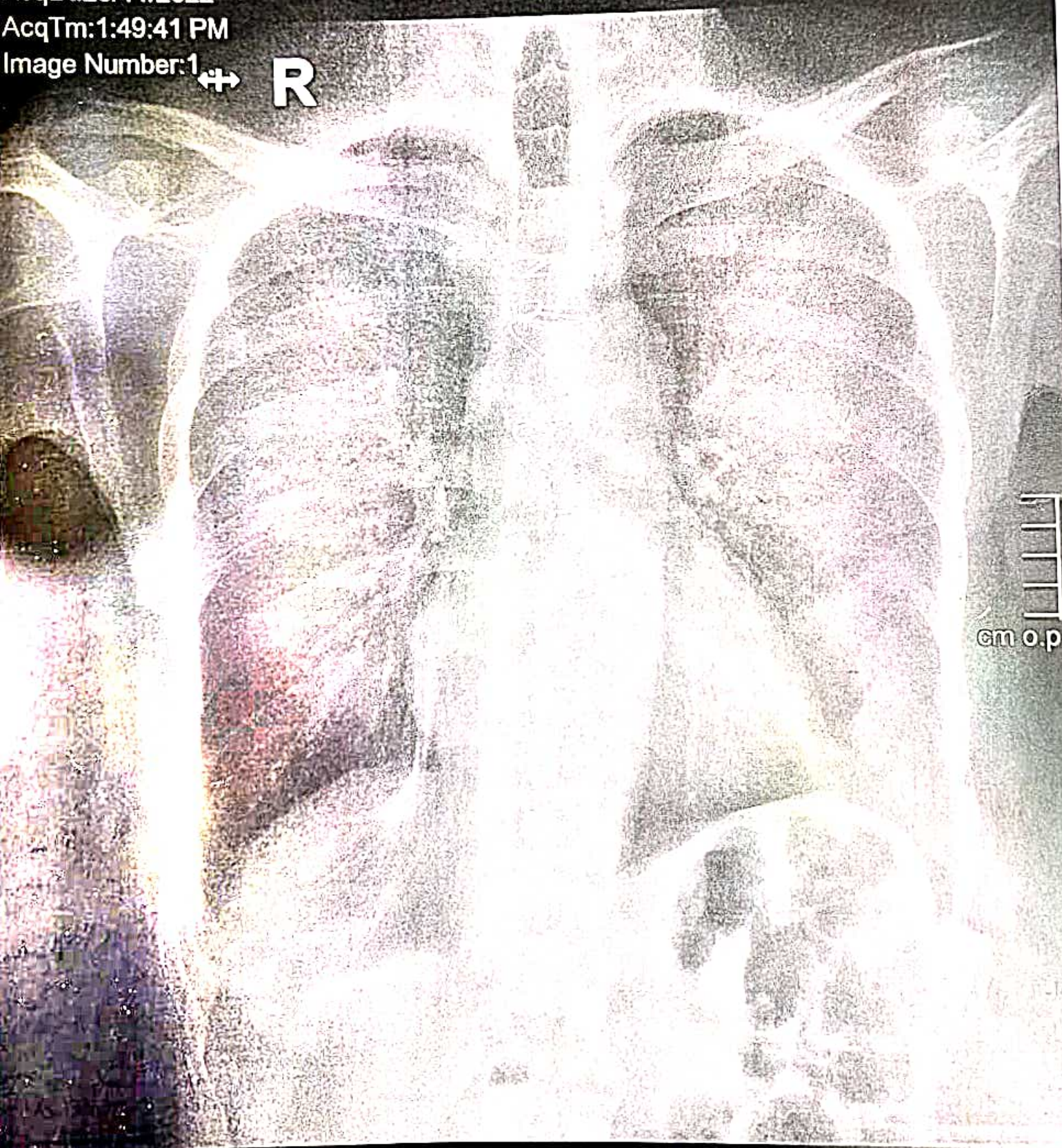
