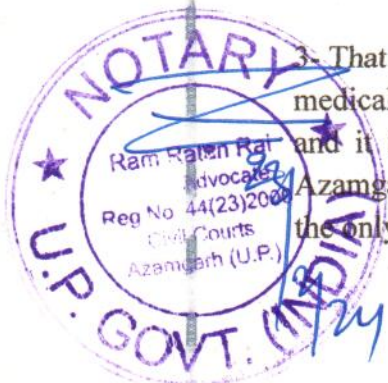
Affidavit

I, the deponent Tarif Mustafa Khan S/o Mr. Mohammad Mustafa Khan, aged 33 years, R/o- House No. J-10, Judges Colony, District- Azamgarh, presently posted as Nyayadhikari, Gram Nyayalaya at Tehsil- Mehnagar, District- Azamgarh hereby solemnly affirm and state as under-

1- That my father Mr. Mohammad Mustafa Khan, aged 75 years, has suffered a brain stroke (ISCHAEMIC CVA (Right Basal Ganglia Infarct)) on 06.12.2023 causing him left sided hemiplegia. He was admitted in the Nova Hospital, Lucknow on the same day. Thereafter, he had to be shifted to ICON Hospital, Lucknow on 07.12.2023. He remained admitted in the ICON hospital till 12.12.2023. The left sided hemiplegia has made my father bed ridden.

2- That my father has already been suffering from other co morbidities- hypertension, diabetes, osteoarthritis, spondylitis and prostrate diseases. The aforementioned co-morbidities have made my father's condition very sensitive. Looking at the present condition of my father, treating doctors have suggested that he will take a considerable time to be able to recover from this medical condition and have emphasized on the fact that he requires specialized treatment, continuous monitoring and continuous nursing.

3- That my father is under treatment for the said diseases in District- Lucknow as the desired medical treatment could well be provided there. I am currently posted in District- Azamgarh and it is not possible for me to provide the desired treatment to my father in District- Azamgarh. I am the only son of my parents. My parents are totally dependent upon me. I am the only male member in the family to look after my ailing father.

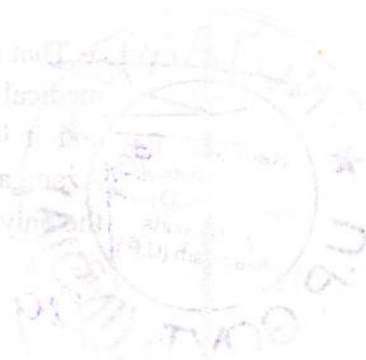
