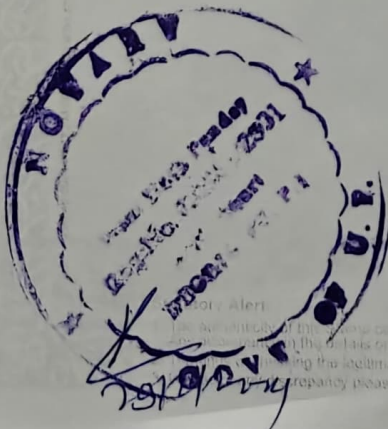

6-that the deponent swears that the contents of this affidavit are true and correct.

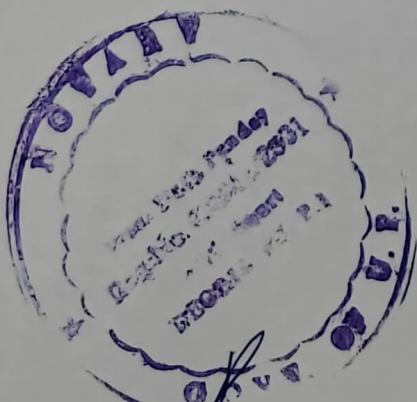
