Through affidavit Amit Kumar-I, age- 36 years, S/o- Sri Gajendra Prasad, R/o- Colony-Phulwaria, Post-Shivpure New Colony, Rustampur, Gorakhpur.

With due reverence it is most humbly submitted that the applicant is posted at Prayagraj from April 2021 as Addl. Chief Judicial Magistrate. That vide Hon'ble High Court Notification no. 1795/Amin(Services)/2023 dated July 15, 2023, the Hon'ble Court was pleased to notify the applicant as ACJM (northern Railway), Prayagraj. That pursuant to the above notification the applicant took charge as ACJM (Northern Railway), Prayagraj on July 17, 2023. That the applicant is due for Annual Transfer from Prayagraj in the coming Annual transfers of the year 2024 but it is most humbly submitted that currently only 5 months have ensued since the applicant took charge of the Court and that only 8 months shall complete in the above Court till March 2024.

It is also submitted that the applicant is trying to perform to the best of his abilities and under the directions as given to cater to the responsibilities attached to the above post and that till date there has been no dereliction or omission on part of the applicant.

The younger brother of the applicant is also undergoing his studies at Prayagraj and is living with the applicant. The applicant's home town is at Gorakhpur where the applicant's parents live, who are also about 70 years of age. Gorakhpur is connected by direct train route from Prayagraj. Thus, the applicant is able to take care of his parents as well.

For the aforementioned reasons, the applicant most humbly requests that if the applicant be granted stay at Prayagraj for one more year, it will be helpful for the applicant to fulfil the professional as well as personal responsibilities. The applicant ensures his good performance with respect to the important post assigned to the applicant by the Hon'ble High Court.

Thus, the applicant prays to your kindness to place this representation before the Hon'ble Court with most humble prayer for stay at Prayagraj.
