Most respectfully I have to submit that I am posted as Spl. Judge (E.C.Act)/Addl. District & Sessions Judge at Pratapgarh. I am due for Annual transfer this year.

Due to my peculiar and compelling problems I most humbly pray to Hon'ble Court for my transfer from Pratapgarh on the following grounds for sympathetic consideration of Hon'ble Court.

1. That nearly 3 years back I suffered heavy inflamation in my legs and severe Lumber pain. On the basis of the investigations, Doctors at Meerut diagnosed me suffering with Ankylosing Spondylitis/SPA (axial)/Inflammatory Sacroilitis in my spine and incompetent perforators in legs. Doctors referred me for AIIMS, NewDelhi for further management. 2. That my daughter, aged about 11 years is a patient of Allergic Bronchitis. In case of Bronchiol attack she requires immediate Specialized medical care and attention. Doctors are also of the opinion that she may get better treatment at New Delhi/Higher Centre.

In view of my aforesaid peculiar and compelling problems and circumstances it is most humbly prayed Your Honour kindly to move the Hon'ble Court to consider my problems sympathetically and to transfer me from Pratapgarh to any place near New Delhi or Meerut as mentioned in the proforma.

For this act of kindness, I and my family will always remain grateful to the Hon'ble Court.
