Subject: **Representation for Pre-mature transfer in Annual Transfer-2020**

Sir,

Most respectfully it is humbly submitted that I am posted in Balrampur Judgeship as Addl. District & Session Judge (F.T.C.). District Balrampur is a small township, situated in the tarai region of Himalaya. In District Balrampur, Judicial Officers have to face problems of insufficient infrastructure, poor medical facilities and other problems related to Basic necessities of life. District Balrampur is Situated at the distance of about 425 Km from my home district Etawah . There is no direct train route or road highway between the two cities, I have to travel this distance in phases approaching various local routes.

My son Atharv Gupta (age about 03 years & 3 month) born in Allahabad in August 2016. Since his birth, Atharv is suffering from problem of low immunity and various Infections. At the time of birth, Atharv was hospitalized in Neo Natal Intensive Care Unit (NICU) or Kamla Nehru Memorial Hospital, Allahabad for 11 days. After hectic efforts of Pediatricians of that Hospital and other well known pediatricians of district Allahabad, his life could be saved. Since then, he has faced several episodes of recurrent Lower Respiratory Tract Infection and Urinary Tract Infection (UTI). For these diseases, I arranged high level medical treatment of my son in various reputed Hospitals of District Allahabad, Kanpur, Etawah and in Madanta Medicity Gurgaon. These diseases require intensive medical treatment. But such high level medical facilities are not available in District Balrampur. Balrampur has humid atmosphere, with heavy rainfall and heavy prolonged winter season. In such weather conditions, my son has tendency of repeated respiratory infections & U.T.I. Owing to above circumstances, I am not in the position to keep my son Atharv and my wife with me in Balrampur. Due to recurrent illness of my son, I am forced by above circumstances, to keep my wife & son in my home district Etawah with

my parents.

My father (age about 72 years old), is suffering from severe stage of type-2 Diabities Mellitus, Hypertension, Chronic Kidney disease, Diabetic Ratinopathy, Nafropathy etc serious diseases. My mother (age about 68 years) is patient of Hypertension and Heart Disease. Regular Checkup and follow up treatment of my mother and father is adviced, thus my parents are under regular checkup & treatment of Madanta Hospital Gurgoan . As my parents are old and sick, they are fully dependent on me at this stage of life. It is my pious obligation to look after them and arrange their medical treatment. In such a family scenario myself is the sole person to arrange and manage all the family affairs and liabilities. Having posted in Balrampur, It is very difficult task for me to attend my ailing parents & son in case of any emergency and other related problems.


