Subject:- Representation for over stay of one year at Amroha

Respected Sir,

With due respect I wish to submit that my transfer is due from District Amroha on completion of normal tenure of three years and over stay of one year.

With utmost regard I humbly wish to state that my elder daughter aged 08 years is suffering from a mental ailment called **Autism Spectrum Disorder (ASD)**, due to which she is about two to three years behind of her mental age. She is unable to perform her daily routine work without help and it is difficult for her to communicate properly with anyone. In May 2017, according to the IQ test conducted at Moradabad, my daughter was found to be about 1.5 years mentally behind of her physical age. After that in June 2017, we took her to **Sir Gangaram Hospital, New Delhi**, where a senior neurologist found her having some mental disorder and he alongwith prescribing medicines referred her to **BLK Hospital, New Delhi**. There her IQ and CARS (Childhood Autism Rating Scale) tests revealed significant delay in her General development Score and some features of ASD were found prominent in her. Then as per doctors's advice we arranged a special educator at home for her behavioral therapy and for clinical consultation kept in touch with **DMR Hospital, Moradabad, a pediatric neurology centre**. In September 2017 the doctor referred us to **AIIMS, New Delhi**, where also my daughter was found to be having Autism Spectrum Disorder (ASD).

As per the advice of pediatric neurologists of AIIMS, New Delhi, my daughter's medication is going on and as per their requirement of regular follow up we are regularly visiting AIIMS.

When the doctors found that special educator at home couldn't serve our purpose properly and felt that my daughter requires regular occupational and speech therapy at a special centre, we took her to **Divya Neuro Rehabilitation Centre, Ghaziabad** in November 2018 where her therapy started in December 2018. Since then her regular speech and occupational therapies are going on **almost twice a week**. In last one year there is remarkable improvement in my daughter and she is going on at a very good pace.

I also wish to submit that along with medicinal support my daughter needs family support for social exposure, which, here at Amroha


is being provided by my parents who reside in Moradabad, my home district, which is just 30 Kms away from Amroha.

Ghaziabad is about 100 Kms and Delhi about 120 Kms away from Amroha. Thus, from my present place of posting, we are able to manage regular visits to Ghaziabad and AIIMS, New Delhi . Hon'ble Court had been very kind to allow my stay application last year, due to which we could achieve significant improvement in my daughter and we have travelled almost half way in this respect. Next one year is very crucial for my daughter's mental development. If I will be transferred to some other station my daughter's mental growth will certainly be obstructed and her future will be affected adversely.

I, therefore, very humbly request you to place my representation before the Hon'ble Court for kind and sympathetic consideration for over stay of one year at Amroha.
