Sub :- Regarding Stay for one more year in Bareilly after completion of normal tenure (3 years)

Sir,

With due respect my humble submission about above noted subject is that —

- 1- This is my **first** 'stay application' during my **whole service period** (appx. **15 years**). Before this, I have already been completed normal tenure (3 years) of posting in all stations.
- 2- I have four sons, out of which age of first son is about **11** years, second is about **8** years and last two is **twins baby**, whose age is about **2 + years**.
- 3- **Only my wife** doing care & take (maintenance) of **twins baby** and other sons, because, no any other relative members reside with my family at my residence in Bareilly.
- 4- Unfortunately, my wife is suffering by spinal & knee joint disease. According to radiological report (M.R.I.) of whole **SPINE, B/L ST & HIP JOINTS** and **LEFT KNEE** i.e. -
 - I- **MILD FOCAL RIGHT PARACENTRAL DISC PROTRUSION AT L1-2 LEVEL CAUSING INDENTION OVER VENTRAL THECAL SAC WITHOUT SIGNIFICANT CANAL STENOSIS/ NEURAL FORAMINA NARROWING/RADICULOPATHY.**
 - II **MILD DISC HERNIATION AT L4-5 LEVEL CAUSING MILD INDENTATION OVER VENTRAL THECAL SAC, B/L NEURAL FORAMINA & B/L EXITING NERVE ROOTS.**

- III MILD DISC BULGE AT L5-S1 LEVEL WITHOUT SIGNIFICANT CANAL STENOSIS/ NEURAL FORAMINA NARROWING/ RADICULOPATHY.
- IV SMALL SUBARTICULAR CYSTIC AREA OF SIZE 08X09MM AT MEDIAL FEMORAL CONDYLE & FEW OTHER SMALL CYSTIC AREAS IN TIBIAL SPINE REGION, MILD EROSION AT ARTICULAR SURFACE OF PATELLA, SMALL MARGINAL OSTEOPHYTES AT SUPERIOR INFERIOR PATELLAR MARGINS, MEDIAL FEMORAL & TIBIAL CONDYLAR MARGINS SUGGESTING MILD OSTEOARTHRITIS.
- V GRADE II INJURY / DEGENERATIVE CHANGES POSTERIOR HORN MEDIAL MENISCUS.



- 5- Treatment of my wife is continuing to '**Rohilkhand Medical College, Bareilly**' and expected to be continued minimum **one year more** as opinion given by concern Consultant/ Physician. A copy of prescription attached herewith in **PDF file** .
- 6- It is also important to mention here that spread of '**Novel Corona Virus (Covid-19)**' increased to very serious pandemic condition in District Bareilly. According to data issued by authority concern, in spread of Corona Virus District Bareilly is constant at **9th** position across Uttar Pradesh State.
- 7- In this very serious, abnormal and pandemic situation, if my transfer will take place, then, I and my family also will face **consequential hardship** and may be **fatal** for my wife specially and other family members in general.

It is therefore, requested to kindly be placed this application before Hon'ble Court for their kind consideration. I am also pray to Hon'ble Court to kindly consider sympathetically **my obstacle hardship** and may kindly be pleased to allow stay application. I will be highly grateful to Hon'ble Court life long.


