Presently due to Covid - 19 corona virus pandemic we are unable to take him to the center. His occupational therapy is still not completed.


Therefore, I again request you that taking into account the factors above mentioned, kindly stay my transfer for one year in the judgeship of Kanpur Nagar.

### CHIEF COMPLAINTS

Shambho's father reported that he does not concentrate on the task that he is allotted. His hand writing is poor. He engages in irrelevant talking. He gets restless when taken to new place. He does not have established relationship with peers. His initiation and interaction is limited with children.

### BACKGROUND INFORMATION

Shambho's mother had no complications during pregnancy. As reported, he is a full term child, born through caesarian delivery. Birth cry was immediate.

His developmental milestones were age appropriate. He could sit on his own by 7<sup>th</sup> month. He started walking at 13<sup>th</sup> month. He said his first word at the age of 12 months. His speech regressed around the age of 18<sup>th</sup> month, but he started showing progress in speech and language at the age of 2 years.

## SCHOOL/THERAPY HISTORY

Shambho started regular schooling at the age of 2 years 6 months.

His school has been changed once. He has attended K.G Jr. twice.

## OBSERVATION

As observed Shambho is an active child. He made appropriate eye contact. He was not referring to the person whom he was talking to. He was just continuously speaking irrelevantly. When he was asked questions based on certain concepts, he did not give to the point answer rather he was talking around the point. Initially during the assessment the rapport was not established between the assessor and the child but gradually he become compliant. His attention was difficult to arouse and sustain.

## TEST ADMINISTERED

The following tests along with clinical interview and observation were used for the purpose of assessment:

- Vineland Social Maturity Scale- Indian Adaptation.**
- Development Screening Test.**
- ADHD Diagnostic Teacher Rating Scale.**

## ASSESSMENT RESULTS AND INTERPRETATION

### **a) Vineland Social Maturity Scale**

To assess the child's Adaptive Skills and Social capabilities Vineland Social Maturity Test was administered on which he obtained a Social Age (SA) of 6 years with the corresponding SQ of 88, suggestive of low average Socio- Occupational Functioning.

### **b) Developmental Screening Test.**

On Developmental Screening Test, the child obtained a Developmental Age (DA) of 5 years 11 month with the corresponding DQ of 85, suggestive of low average intellectual functioning.

## c) ADHD Diagnostic Teacher Rating Scale

On ADHD Diagnostic Teacher Rating Scale, Shambho meets the criteria for inattention & hyperactivity-impulsivity type.

### CONCLUSION AND RECOMMENDATION

Taking into account the information shared by the child's father, the observation and interaction made during the session indicate that the child does not have learning difficulty. Due to the condition of hyperactivity and inattention he faces difficulty in attending to the task at hand. He also has difficulty to sustain attention and lacks to follow it through.

It is recommended,

- Child should be engaged in activities that involves his thinking skills- such as problem solving and self-control.
- Setting goals for behavior change and following it through with incentives.
- Social training is essential for the child.
- Activities like – listening and narrating incidences and stories
- Include physical activities in everyday routine.
