Sub. : **Representation regarding Premature Transfer from present
place of posting on medical ground.**

Sir,

Most respectfully, I have to submit before the Honourable High Court at Allahabad that I am applying for Premature Transfer from the present place of my posting on the following grounds:-

1. I have joined U.P. Judicial Services vide Hon'ble Court Notification No.1807/Admin (Services) 2018 dated 13th June, 2018 at District Etah on 14th June, 2018. From that date, I am posted at Etah and will be completing my three years on 13th June, 2021.

2. I am still unmarried and my hometown is in Aligarh. Due to the ill health of my father, my mother won't be able to stay with me and my parents live alone at home. I have two brothers, one in Govt. job posted at Ludhiana and the other studying in Delhi. Hence, I am staying alone at Etah and no one can come easily to take care of me.

3. It is pertinent to mention here that from July, every consecutive month I had severe pain in my abdomen and it generally lasts for weeks. I went for a check-up at my hometown where the Doctor directly recommended me to go to Delhi or Chandigarh, considering I am still unmarried and of young age. I consulted the Retired AIIMS Director and gyne-lap surgeon at Paras Hospital, Gurgaon where she diagnosed me with Deep Endometriosis of stage 4 with severe adenomyosis. For this, I was asked to go for surgery of the lower abdomen and required to be on medicine and regular strict follow-up. The doctor strictly recommended for MRI and USGs (Ultrasound Scans) to be done regularly and only by an expert/specialist as it is a chronic disease. Moreover, this has to be monitored properly as there is a 90% chance of its recurrence even after surgery. Further, it is said that it affects other body parts, mainly affects female parts. In a

worse condition, the only option that remains is to remove that body part completely. As my whole family was worried about my condition, I even took an opinion from a senior gynecologist surgeon in PGI Chandigarh and she said the same thing. She told that it has already spread wide in my lower abdomen and has affected a large area. So, further risk should not be taken. To prevent any more damage, I have been advised to be on regular check-ups and prompt treatment.

4. It is important to note here that as I am in utmost need of extensive care and proper treatment at this very point of my age, which I am not able to get and that has affected my health adversely for the past few months. Finally, I have started my proper treatment under a very reputed doctor, retired from AIIMS, practicing in Gurgaon. With the ongoing treatment of my chronic disease, I have to commute alone from Etah to Delhi for my follow-ups, USGs tests, and medicines. Moreover, Etah, being a very small city, lacks even good primary medical facilities. In that scenario, I have to rush to Gurgaon in case of pain or any adverse symptoms. This creates a lot of mental as well as physical stress on me, which further takes a toll on my health.

5. While considering all the aforesaid reasons, it is my humble submission to Hon'ble Court to kindly consider my representation and be pleased to transfer me to Gautam Buddh Nagar or Gaziabad or any station near Delhi. This will allow me to take proper treatment and avoid a lot of stress caused due to frequent travel to Gurgaon and back. And more importantly, this will allow me to discharge my official duties effectively and efficiently.


You are, therefore, most respectfully requested to kindly place my representation before Hon'ble Court for its kind consideration. I shall be highly obliged and ever be grateful.
