Subject – Request for stay at Aligarh on Compassionate Grounds

Sir,

1. Reference is made to Hon'ble High Court letter No C.L. No. 24/Admin. (Services)/2021, dated 24 September, 2021.
2. With utmost reverence, I humbly submit that I was initially posted to Aligarh Judgeship from Bareilly vide Hon'ble High Court Notification No 1650/Admin (Services)/2019 dated 10 April 2019.
3. My husband is a commissioned officer, a lieutenant colonel in Indian Army and is presently posted to an advanced location in Eastern sector. I had submitted an application for posting to Aligarh for looking after my aged parents and the Hon'ble Court was kind enough to consider my application sympathetically and I was posted to Aligarh. My father who was suffering from multiple chronic diseases such as cardiac, hepatic, neuro, eye renal and rheumoid arthritis passed away on 09-07-2021. I have two brothers and elder one is unmarried. My elder brother has become a patient of psychiatric disorder and depression and is presently living with me and is getting treatment from Delhi whereas the younger brother is in United Kingdom. After sudden demise of my father and the psychiatric disorder/depression of elder brother my mother is in a pathetic and helpless state. She is not in a position to take my elder brother to Delhi for his treatment. Thus virtually there is none at home to take care of my aged mother and lunatic brother. My mother too is aged and infirm and unable to take my brother to the hospital. I have only a 13 years old girl child and my mother takes care of her in my absence.

At this critical juncture and in the hours of need, my mother look towards me being the only ray of their hope for all sorts of help and support for her treatment as well as treatment and routine care of my elder brother. . My mother too is aged and is a patient of gout and she herself is unable to walk properly and therefore she is unable to take my brother from Aligarh to Delhi for his treatment and it is me who accompanies my elder brother to hospital for his treatment.

In view of the above elucidated facts, I humbly request that if I am permitted to remain at Aligarh for next one year, it will prove to be a great help to my aged ailing mother and brother as well for me too and thus I shall be able to discharge my duties effectively and simultaneously I shall be in position to take care of my mother and brother in this critical situation as i just lost my father suddenly to cardiac arrest. With the pace of recovery by the treatment being given to him, my elder brother shall be able to complete considerable portion of his treatment and may recover and thus shall be able to come out of this tragic condition. Therefore I entreat that my representation be put up before the Hon'ble court for kind and sympathetic consideration of my earnest request for stay at Aligarh on humanitarian grounds for one year.
