Thereafter he again got fainted after one month and afterwards had repeated episodes of seizure attack. I consulted doctors in District Gonda and Lucknow and AIIMS Delhi also. According to doctors, my son developed disease of seizure/ Fits for which his continuous medication is going on .

The applicant, most respectfully, submits that I have only one issue, my son, who is everything to me. My son's sudden sickness has disturbed me emotionally. Before this posting, my son has always been in good health and never had any prior history of seizure. Counsellor in AIIMS Delhi advised me very clearly (orally, counsellor was making me understand) that my son is under stress and I need to do things which make him happy and I was suggested by Pediatric counsellor to take my son to a different environment.

My son who is just 10 years old, a very tender age, again and again expresses that he misses my last posting place Pilibhit very much. My son is very emotionally attached to my last place of posting Pilibhit. Since I am a mother also, it is my responsibility and moral duty also that I should do every effort to make my son happy.

Therefore, the applicant , most humbly begs with folded hands that my representation keeping in view the welfare of my only child, for premature transfer from District Gonda to any district nearby Pilibhit preferably District Bareilly, (from medical facilities point of view) or Rampur kindly be placed before Hon'ble Court for sympathetic and kind consideration.
