Subject : - In respect of considering my stay of transfer at Allahabad.

Most Respected Sir,

With utmost reverence, in response to the Hon'ble Court's C.L. No. 24/Admin (Service)/2021, Dated : September 24, 2021 regarding Annual Transfer – 2022, I am submitting my application for stay of transfer at Allahabad & choice of stations for posting on the prescribed Proforma as I am going to complete three years of my normal tenure at Allahabad judgeship by April 2022.

My humble submission is that my widow mother-in-law is around 69 years old and suffering from prolonged illness of Kidney disease since 1996. She has undergone Kidney Biopsy test for the same at Sanjay Gandhi Post Graduate Institute Of Medical Sciences at Lucknow. She is still under constant supervision and treatment at said Institute (photo copy of present Doctors prescription and relevant medical papers are enclosed herewith).

In addition to the above, I am also to submit that my husband is working as Assistant Registrar, High Court of Judicature at Allahabad which is a non-transferable job. Government Order No. 19/01/1976 Karmik-1 dated 05.01.1976 provides that if husband and wife both are in Government service, then they should be posted together as far as possible. The scheme referred to in above G.O. has also been upheld by the Hon'ble Supreme Court in Home Secretary, U.T. Chandigarh v. Darshjit Singh Grewal, J.T. 1993 (4) SC 387.

It is also submitted that my only son is around 3 years old who constantly needs mother's care and support at this tender age. The presence of my husband with us for the next one year will be of a great help, both physically and mentally.

Keeping in view the above facts and circumstances my stay of transfer at Allahabad is very essential, hence, I am not in a position to get posted at any station other than Allahabad because



GROSS:

The kidney is enlarged.
 Both capsules.

MICROSCOPIC:

The renal cortex shows a focal segmental glomerular sclerosis. The segmental increase in mesangial matrix and hyaline thickening of glomeruli show sclerotic changes with hyaline thickening. Occasional foci of tubular atrophy and some interstitial fibrosis. Interstitial foam cells are present. The glomeruli appear largely unremarkable.

DIAGNOSIS : FOCAL SEGMENTAL GLOMERULOSCLEROSIS.
