I have the honour to submit that after the completion of three year tenure my annual transfer is due in year 2022. I am sending my choice of stations on precribed performa for matured transfer.

It is further submitted that in the very first year of my posting at Aligarh I got severe Heart Attack on dt. 05/08/2021 at midnight. By the help of the then CJM and other Ld. Judicial officer I was brought to (J.N. Medical) AMU Hospital immediately in ambulance. The Medical Team headed by Dr. Rabbani did Angiography followed by other neccesary treatment in Heart attack (papers annexed), kept me admitted for three days. I got discharged on date 09/08/2019 with their prescribed treatment (Discharge certificate annexed). Thereafter my family took me to the Safdarjung Hospital, New Delhi. There again the concerned doctor/cardiologist got my E.C.G. and other neccesary Test and refered to me the neccesary treament and asked that I have to take the treatment/prescribed medicine for heart permanently and advised me to be under routine checkup and treatment continuosly. Even after that I am suffering from Heart problem and getting the treatment regularly from Safdarjung Hospital Delhi.

Above all it is pertinent to mention that my husband is a Govt. Employee working in Commercial Tax Dept. in Ghaziabad. My children reside with him, my daughter doing LLB first year from IME College Ghaziabad and son got admission this year for graduation first year from Delhi University (details are mentioned in prescribed proforma). My family lives in Ghaziabad for the reasons above. And I, inspite of suffering from heart disease, have to live at distant place all alone with fearful mind concerning health issue. In this situation, I genuinely require any district as my posting near to Ghaziabad (where my husband resides) and I am under treatment.

Hence in above circumstances its necessary for my well being to be at a place from where I can continue my treatment from Safdarjung Hospital, Delhi and in case of any extigency can reach there feasibly. (Out of abundant only few medical papers are annexed for kind perusal)

It is therefore requested that you may kindly be pleased to accommodate me to any of the mentioned stations. I will be highly obliged.
