Subject: Regarding Representation for Premature Transfer on having little child and Spousal ground.

Respected sir,

With due reverence on the abovementioned representation, applicant most humbly beg to submit on the following grounds:

1. That the applicant is posted as Secretary, District Legal Services Authority at District Lakhimpur Kheri by the Hon'ble High Court notification dated 09.04.2021.
2. The Applicant was blessed with a baby on 21.12.2020 (copy annexed) who is just 11-month-old and require extreme care and attention of both the parents.
3. That Besides this, the husband of applicant is posted in Noida, District Gautam Buddh Nagar as Assistant Commissioner, Commercial Tax (S.G.S.T) since 2017.

It is most respectfully to state that applicant was posted on deputation in LARRA in Dist. Gautam Buddha Nagar in the Cadre of Civil Judge (Junior Division) and on account of promotion to the Cadre of Civil Judge (Senior Division) by the Hon'ble High Court Notification no: 1391/Admin. (Services)/2021 dated 09.04.21 applicant was transferred from District Gautam buddha Nagar to District Lakhimpur Kheri. There as applicant have completed only 2-year 2 months tenure in Gautam Buddha Nagar.

Also, it is most respectfully submitted that as applicant's husband is posted in District Gautam buddha Nagar, Noida which is at a distance of 580 km from my posting place. And due to considerable distance between the two districts the applicants is facing lots of difficulties while performing her duties and taking proper care of her new born child in the District Lakhimpur all alone without the presence of husband and family. Also, it is to further submitted that the being a new born baby, the health of applicant 11-month-old child is not remained good and for his treatment and check-up applicant has to visit Noida frequently which cause great

inconvenience for applicant and her child to travel such long distance which usually takes 11 hours to reach.

Further, it is submitted that as per the G.O No: 19/01/1976(1)-karmik-I which provides that if both husband & wife are government employees/ officers then while posting them efforts should be made to post them together at one place.

It is therefore most humbly prayed that due to need of extreme care and attention of new born child by both the parents' applicant may kindly be posted along with her husband (where her husband is also posted and residing) at district Gautam Buddh Nagar or to any nearby adjoining districts. So that applicant may be able to take care of her child and perform Marital and official responsibilities.

In view of the foregoing, it is most humbly requested that my application may kindly be placed before the Hon'ble Courts for kind consideration. I would be highly obliged if my request is met with and would be grateful to your kind self.
