Most humbly and respectfully, I beg to submit the following for your kind and simpathatic consideration---

1- That I was tranferred form District Gonda to Atarra (Outline court, Banda) in October 2015 and Promoted and posted as Civil judge (S.D.) FTC in Feb 2o18. Thereafter I was transferrd to District Bareilly vide Hon`ble courts Notification no. 1379/ Admin (Services) 2019 Dated: Allahabad :April 10, 2019.

2- That I have been performing my official duties with all sincerity and intigrety at my present placeof posting i.e.Bareilly.

3- That my wife Mrs. Nishi Singh is suffering from **vitiligo desease** from last four- five years due to which my wife is suffering from acute physical, mental pain and depression. She was treated for her said desease from **Aimil Helath Care and research Center Delhi, KayaKalp Global Faridabad, (Haryana),Maharishi Vitiligo Centre Delhi,**and presently her treatment is going on at **Rohailkhand Medical College, Bareilly.** Where the docters are treating her with **Narrowband therepy.** As per the docters, she needs continous treatment for long term. Presently the treatment which my wife is undergoing is not available at any nearby districts. This kind of treatement is ony available at district Bareilly besides Dehli. In such case my transfer from district Bareilly will breaks my wife's medical treatment which is very essential and it is of utmost important for her wellbeing and health.

4- That to add to my miseries, my elder brother Late. Mr. Himanshu Kumar (Court manager, Amroha) also untimely passed away on 22-3-2021. Now in the family of my brother his wife, minor daughter (13 years) and son (8 years) are the only survivours. That all are residing at District Moradabad. My both the parents have also Passed away very long time away. In such circumstances, the responsibility of taking care of my brother's family is on me. It will be more easier for me to carry out my responsibilities towards my Late brother's family from my present place of posting.

5- That in such circumstances for my wife's very necessary and proper treatment, it has become very essential for me to be posted at my present place of posting i.e. Bareilly for further one more year.


I most humbly request you to kindly place my representation before the Hon' ble Court for sympathetic consideration for staying my transfer at my present place of posting i.e. Bareilly.
